Greg Lazzaro will work with Leigh Pearson to implement a communications plan, including engaging with 'All of Government' – including ACC. This will include three things the Transport Agency is doing well and three things the Transport Agency would like to do – to enable simple conversations. Mark Ratcliffe advised the Board that the Transport Agency had shared with the Minister, the Road Fatality Spreadsheet and will provide this to him in his weekly report going forward. A Board Member reported back on the nationwide 'Pause for Health and Safety' event, which they attended on site in Auckland this morning, which they saw was very positive.
