Request made under the Official Information Act 1982

Thank you for your request for information under the Official Information Act 1982, which was received by the NZ Transport Agency (NZTA) on 14 June 2013 having been transferred from the Greater Wellington Regional Council. You requested:

• '... a list of the safety failures for each Go Wellington bus as picked up by the Police during their safety checks over the months of April and May 2013 (up to the date of my request)?'

As part of the NZTA's regulatory function, periodic random inspection of commercial vehicles is undertaken to identify and mitigate existing or emerging compliance issues. This approach includes inspections undertaken while the vehicles are in their normal operating environment, and often take place on the road.

In April 2013, NZTA and NZ Police focussed activities on City Transport Limited, who operate under the trading name of Go Wellington and are owned by NZ Bus Limited. This activity resulted in a number of faults being identified, ranging from minor to moderate.

NZ Bus Limited have taken these findings seriously, and have instigated a full review of the maintenance and operation of their fleet, and have worked proactively to meet targets that have been set to improve the overall safety of their operations.

It should be noted that the NZTA is satisfied that the issues identified in this report have been rectified, and that there are maintenance programmes being developed and enacted to ensure continued compliance.

The following is a list of dates and faults for separate buses found during April and May 2013. It should be noted that Go Wellington operate 223 buses in the region.
