**Request made under the Official Information Act 1982**

Thank you for your email of 19 December 2014 requesting the following information under the Official Information Act 1982:

- 'All information on your survey of visiting drivers. This includes final and draft copies, copies with tracked changes, source information, and correspondence over how the survey will be presented or changed.'

The following is an extract from the Visiting Drivers Signature Project Working Group meeting notes from the meeting held on 20 October 2014:

**Evaluation of the Steering Wheel Tag - Corinna Bennett NZTA**

- The group agreed that it was worth doing a wider summer trial.
- There was discussion about whether to roll this out across the country. Kate Meldrum indicated that rental companies might be prepared to pay for this. Steve Hanrahan agreed, as this fits in with the rollout of the TIA guidelines across the country. There is still the issue of how to reach operators that are not members of RVA or TIA. TIA is discussing the guidelines with some non-members.
- Steve also advised that the Responsible Camping Forum is considering messaging on the interisland ferry and he will raise the possibility of including road safety messaging. He will report back on this.
- The issue of funding was considered. Steve Hanrahan and Kate agreed to explore this.

**ACTIONS:**


- Steve Hanrahan and Kate Meldrum to develop a proposal for funding the steering wheel tags and report to the Working Group.
- Steve Hanrahan to report back to the group on his discussions with the Responsible Camping Forum and the interisland ferries.
