Request made under the Official Information Act 1982

Thank you for your email of 27 February 2015 to Andy Knackstedt requesting information about physical and verbal abuse toward testing officers. The responses are provided under your questions.

1. 'The number of complaints made to NZTA and/or NZDL regarding verbal threats and physical attacks made against testing officers during both restricted and full licence tests from January 1 2013 to the soonest available records'.

As at 9 March 2015 there were 45 complaints made to NZDL.

We are unable to supply information for question four as this is a human resources matter that the Transport Agency has no involvement with. The information you seek is likely held by NZDL in its private capacity and I suggest you forward this question to them. However, please be aware that NZDL is not subject to the Official Information Act.

Please note that there are no specific obligations in the contract regarding the safety of testing officers. There is a standard expectation that NZDL will comply with all obligations relating to the Health and Safety of its employees as stipulated in employment legislation.

With respect to the information that has been withheld, I do not consider there are any other factors which would render it desirable, in the public interest, to make the information available.
