Request made under the Official Information Act 1982

Thank you for your email of 11 October 2016 requesting the following information under the Official Information Act 1982 updated figures in respect of cost recovery from motorists for 2013,2014, 2015 and the year to date. This information is set out below.

The NZ Transport Agency can recover costs from those responsible for crashes that affect the state highway network. This falls within our responsibilities as manager of a public asset and is the same principle that applies when a driver at fault in a crash causes damage to any property. The costs we seek to recover include traffic management and repair of damage to roadside equipment or signage. The amount of roadside equipment we install on the state highway is increasing over time. This includes safety barriers, urban design features and infrastructure for technology such as variable messaging signage. We contract maintenance and operation of the state highway network to contractors for each network management area around the country. Since 2013 we have been progressively rolling out a new form of maintenance and operation contract known as 'network outcomes contracts'. This roll-out is nearly complete. Prior to 2013 we recovered costs directly from those responsible for crashes. Under the network outcomes contracts, contractors recover the costs directly. The consistency and accuracy of the data recording cost recovery is likely to have improved under the network outcomes contracts.
