Request made under the Official Information Act 1982

Thank you for your email of 20 February 2019 to the Wellington City Council requesting the following information:

Can I please have all written communication, including emails, letters, and meeting notes, in relation to the funding of Let's Get Wellington Moving, between the council, councillors, and mayor, to the Transport Minister, and the Ministry of Transport, since August 2018.

On 21 February 2019, your request was transferred to the NZ Transport Agency for response under the Official Information Act 1982. Let's Get Wellington Moving (LGWM) is responding because information requests to any of the programme partners about LGWM are considered under the joint protocol for information requests related to LGWM.

On 20 March 2019, we extended the timeframe for responding to your request by 10 working days to allow for consultation.

The information within scope of your request is itemised in the attached document schedule. Copies of the documents for release are also enclosed. Some information is withheld from them under section 9(2)(a) of the Act, to protect the privacy of natural persons.

Some information is withheld from Document 5 under s9(2)(g)(i) of the Act, to maintain the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any department or organisation in the course of their duty.

Some information is also withheld from Document 16 under section 9(2)(f)(iv), to maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by Ministers of the Crown and officials.

You will note that some of these communications are between myself and the Ministry of Transport. I have included these because I have taken the view that, when I am acting as Programme Director on behalf of LGWM, my communications are in effect also on behalf of the Wellington City Council.

There is further information within scope that I have decided to withhold under the following sections of the Act:

- section 9(2)(f)(iv), to maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by Ministers of the Crown and officials
- section 9(2)(g)(i), to maintain the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any department or organisation in the course of their duty.

With respect to the information that has been withheld, I do not consider there are any other factors which would render it desirable, in the public interest, to make the information available.

Under section 28(3) of the Act, you have the right to apply to an Ombudsman for an investigation and review of the decision to refuse this information. For more information, the Ombudsman website is www.ombudsman.parliament.nz/.
