You may recall before you went away we were in the process of drafting a letter for you to send to WCC about their rainbow pedestrian crossing and inviting them to apply for an exemption under the Traffic Control Devices rule for this crossing. If you need more to remind you of the background to this just let me know.

Attached for your approval is a draft letter that has been prepared by Glen Bunting and Mark Edwards (our experts on this rule) s9(2)(h) [REDACTED] and Emma Speight Regional Director (who has been dealing with WCC). I questioned Glenn on the assessment attached to the letter of the data already provided by WCC as I couldn't follow it and I thought it might need some commentary rather than just a table of numbers and colours. Glenn was very clear that WCC will be able to follow the assessment as it's based on data they sent us and it's all their headings. s9(2)(g)(i) [REDACTED].
