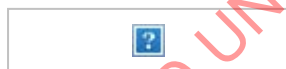

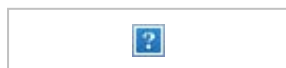

Consultation on the proposal to toll Puhoi to Warkworth will be publicly announced on Wednesday 13 May 2020, with formal public consultation beginning on Friday 15 May 2020.

Once announced, Waka Kotahi NZ Transport Agency are expecting a number of queries from members of the public, including requests for information under the Official Information Act 1982 (the Act).

In response to this, Waka Kotahi are looking to proactively release the attached documents on our website by 15 May 2020. Certain redactions have been proposed in line with the provisions of the Act.
