Request made under the Official Information Act 1982

Thank you for your email of 16 September 2020 requesting the following information under the Official Information Act 1982 (the Act):

... details regarding progress of the Provincial Growth Fund \$137m Tairāwhiti Roading Package, announced in September 2018.

- 1. Please state the value of work NZTA is responsible for?
- 2. Please itemise the location and type of works planned
- 3. Please itemise progress on each job (ie Has it been tendered/ tender agreed/ work started or work planned to start on a certain date/ work finished)
- 4. Please state the value of overall completed work to-date
- 5. Please state the value of work yet to be tendered for
- 6. Please give an estimated date of completion of the overall work package.
- 7. Can you state if NZTA is being hampered in delivery of this package by any lack of skilled workforce and if so is NZTA requesting government help to boost the workforce or doing anything itself to move faster on completing the Tairāwhiti Roading package.
- 8. What stage of the work is currently underway?
- 9. Does NZTA see any risk of losing any of the appointed money from the package due to time delays in completing work?

Waka Kotahi is responsible for \$58.97M of the Tairāwhiti Roading Package (TRP). \$51.15M is directly funded from the Provincial Growth Funding and \$7.82M from the National Land Transport Fund.

Waka Kotahi is not being hampered in delivery of these projects by a lack of skilled workforce. This work has been awarded to a panel of consultants and contractors to ensure adequate resource is available to deliver to the committed timeframes. Physical works will ramp up from November 2020 and we do not expect to lose allocated funding should there be time delays in completing the work.
