Kia Ora,

Thanks for your email.

As you may know, the lease of the Kilbirnie site is a commercial matter between one of our contracted partners, NZ Bus, and the relevant property owner. Greater Wellington Regional Council has no commercial and/or legal interest in the Kilbirnie depot, nor do we have a relationship with the property owner.

Whilst we understand NZ Bus has secured a lease for at least the next two years to allow them sufficient time to identify and develop an alternative site, we do not have any information as to what the property owner's ultimate plans are for the site.

The key from our perspective has been securing confidence that our contracted partner, NZ Bus, has been able to hold a site that it can run some of its operations from and therefore avoid any interruption to our network as a result of any issues associated with its depot (or lack of one).

I hope this answers your question. Let me know if you have any additional questions.
