Hi Out of Scope

There are two inspection sites in the area which are operated by Vehicle Testing New Zealand (VTNZ) – one in Te Awamutu and another in Cambridge. Both sites are available for CoF services by booking only and have wait times of 7-8 days in Te Awamutu and 10 days in Cambridge. There has not been a reduction of services in the area recently. Since 2014, when independent/privately owned sites have been able to issue CoFs, this has provided more options for the public. There is now an independent CoF site in Otorahanga which has taken some pressure of the VTNZ site in Te Awamutu in servicing the surrounding district.

Waka Kotahi has received an application for a third site in Te Awamutu but the site is still under construction. At this stage, we are unable to advise when the new site might be operational or have the ability to carry out CoF inspections.
