- Waka Kotahi NZ Transport Agency recommends the Minister accept the invitation to meet with Horowhenua District Council (HDC), to provide further understanding of the growth in the Horowhenua region, and how the Ō2NL interacts with development areas such as 'Tara-Ika' and its importance to wider regional growth.

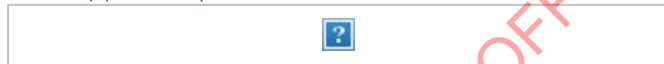

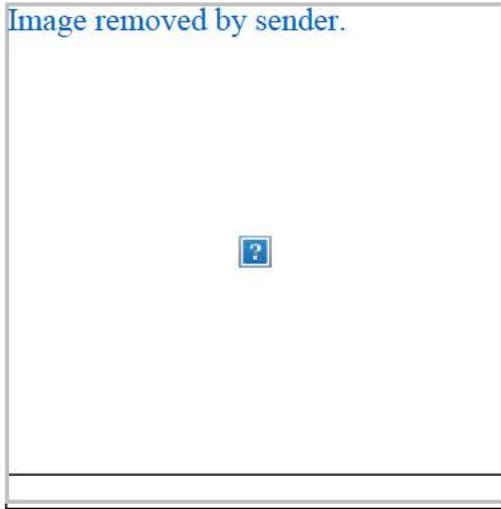
