Request made under the Official Information Act 1982

Thank you for your email of 1 August 2023 requesting the following information under the Official Information Act 1982 (the Act):

Re national ticketing system, we request release in full and in searchable format of:

- All minutes of meetings of the NTS Governance Board (established late 2022 I think)
- The latest two substantive briefings about the project to that board

[...] Have any of the PTAs told WK they cannot go ahead with NTS – at all? Or in the form it was agreed to (late 2022 I think)? Is any PTA asking for changes to make it more affordable? Or have such changes been made/underway?

I have numbered each part of your request for convenience and will answer each in turn.

- 1. Re national ticketing system, we request release in full and in searchable format of:
 - All minutes of meetings of the NTS Governance Board (established late 2022 I think)
 - . The latest two substantive briefings about the project to that board

The documents listed in the enclosed schedule fall within the scope of your request and are attached.

Certain information has been withheld under the following sections of the Act:

- Section 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any public service agency or organisation in the course of their duty.
- Section 9(2)(b)(ii) to protect information where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information.
- Section 9(2)(ba)(i) to protect information which is subject to an obligation of confidence or which any person has been or could be compelled to provide under the authority of any enactment, where the making available of the information would be likely to prejudice the

- supply of similar information, or information from the same source, and it is in the public interest that such information should continue to be supplied.
- Section 9(2)(j) to enable a Minister of the Crown or any public service agency or organisation holding the information to carry out, without prejudice or disadvantage, negotiations (including commercial and industrial negotiations).
- 2. Have any of the PTAs told WK they cannot go ahead with NTS at all? Or in the form it was agreed to (late 2022 I think)? Is any PTA asking for changes to make it more affordable? Or have such changes been made/underway?

No, on all counts.

With respect to the information that has been withheld, I do not consider there are any other factors which would render it desirable, in the public interest, to make the information available.
