I would like figures for:

- The number of deaths involving drugs
- The number of deaths involving alcohol (separated for those above and below the limit)
- The total number of deaths involving alcohol/drugs

Could you also supply these figures broken down by Regional Council territory for the last five years?

- This data is provided from the road traffic crash database; Crash Analysis System (CAS) version 2.6.2
- NZ Transport Agency (NZTA) Waka Kotahi maintains the CAS which is updated once a Traffic Crash Report (TCR) is received from NZ Police sometime after the crash.
- Data is limited to fatal crashes for the years 2014 to 2024 as recorded in CAS to date - 23/01/2024.
- Data is limited to crashes involving drugs or alcohol.
- Drugs means cause 109 'Drugs proven' was a contributing factor to the crash.
- Alcohol above limit or test refused means cause 103 'Alcohol test above limit or test refused' was a factor contributing to the crash.
- Alcohol below legal limit means the breath or blood reading was non-zero but below the legal limit.
- A crash, to be recorded in CAS must have occurred on a road. The CAS definition of a road is any street, motorway or beach, or a place to which the public have access with a motor vehicle, whether as of right or not e.g. a public car park.
- Due to the police reporting time frame and subsequent data processing there is a lag from the time of a crash to full and correct crash records within CAS.
- Fatal crash report data is usually recorded in CAS within one working day of Waka Kotahi receiving it from NZ Police.
- Due to the Covid-19 pandemic, NZ had a 4-level Alert system in place from 21 March 2020 until this changed to a Traffic Light system from 3 December 2021 to 12 September 2022. The amount of traffic on the roads during level 4 lockdowns was greatly reduced, which consequently reduced the number of road crashes. Road movements under the Orange and Red levels of the Traffic Light system would also be reduced due to the restrictions in place, so data from these periods will not align with previous trends.
- The cause of a crash cannot necessarily be attributed to any one factor (eg drugs) as a crash may have multiple factors.
- Drug and alcohol factors for a fatal crash can be updated at a later date when Serious Crash Unit reports and Coroner's reports become available.
- Note that this is a table of road deaths involving a driver with alcohol or drugs. There are a few crashes where a drugged pedestrian or cyclist was killed but the driver had neither alcohol nor drugs in their system. These are not included in the table.
- Total deaths involving alcohol and drugs in a crash means the alcohol and drugs could be different drivers or the same driver.
- A death can appear in more than one column of the table.
- From 1 December 2014 the breath alcohol limit was lowered to 250 micrograms of alcohol per litre of breath and the blood alcohol level was reduced to 50mg of alcohol per 100ml of blood. The previous limits were 400 micrograms of alcohol per litre of breath and 80 mg of alcohol per 100ml of blood.
- 2023 and 2024 data is not yet complete in CAS but these are the current figures from CAS as at 23/01/2024.
- Over time, crash numbers can change a little - either up (eg as late reports are entered) or down (eg as duplicates are removed). Serious crashes can become fatal crashes, fatal crashes
