**Request made under the Official Information Act 1982**

Thank you for your email of 20 June 2022 requesting the following information under the Official Information Act 1982 (the Act):

*Under the Official Information Act 1982, I request a copy of any reports the NZTA Board has received regarding the Road to Zero Strategy over the past 6 months.*

There are five documents that fall within the scope of your request and I have detailed each of them in the document schedule appended to this letter.

Certain information has been withheld under the following sections of the Act:

- section 9(2)(f)(iv): to maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by Ministers of the Crown and officials
- section 9(2)(g)(i): to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any department or organisation in the course of their duty
- section 9(2)(j): to enable a Minister of the Crown or any public service agency or organisation holding the information to carry on, without prejudice or disadvantage, negotiations (including commercial and industrial negotiations)


With respect to the information that has been withheld, I do not consider there are any other factors which would render it desirable, in the public interest, to make the information available.
