## Request made under the Official Information Act 1982

Thank you for your email of 1 September 2022 requesting the following information under the Official Information Act 1982 (the Act):

Under the Official Information Act 1982, I request a copy of all reports, briefings and advice that NZTA provided the Minister of Transport in August 2022, but excluding NZUP reports and excluding Weekly reports.

Where information is withheld, I request that you provide the title and date of the communication/document withheld, the reason for refusal, and the grounds in support of that reason as required by section 19(a) of the Official Information Act.

Due to the large amount of documents that fall within the scope of your request, we are providing our response to you in two stages. On 14 October 2022, we will inform you about the following documents:

- MINO-0435 Potholes, road maintenance funding and new initiatives
- BRI-2534 Additional Waitemata Harbour Connections Engagement
- MINO-0348 (section 9(2)(a)) Rally Support
- MIN-3947 National Ticketing Solution decisions timeline

In the meantime, the information falling within scope of your request is outlined in the below Document Schedule and attached.

Certain information has been withheld under the following sections of the Act:

- 9(2)(a): protect the privacy of natural persons
- 9(2)(b)(ii): protect information where the making available of information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information
- 9(2)(c): avoid prejudice to measures protecting the health or safety of members of the public
- 9(2)(f)(iv): maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by Ministers of the Crown and officials

- 9(2)(g)(i): maintain the effective conduct of public affairs through the free and frank expression of
  opinions by or between or to Ministers of the Crown or members of an organisation or officers and
  employees of any department or organisation in the course of their duty
- 9(2)(h): maintain legal professional privilege; and
- 9(2)(j): enable a Minister of the Crown or any department or organisation holding the information to carry on, without prejudice or disadvantage, negotiations (including commercial and industrial negotiations).

With respect to the information that has been withheld, I do not consider there are any other factors which would render it desirable, in the public interest, to make the information available.

I am also refusing to release the following documents under section 18(d) as the information will soon be made publicly available:
