Request made under the Official Information Act 1982

Thank you for your emails of 26 January 2022 requesting information regarding Mount Messenger bypass project under the Official Information Act 1982 (the Act).

In your email to Sir Brian Roche, Chair, Waka Kotahi NZ Transport Agency Board, you requested the following:

We understand that on Friday 25 August 2017 the NZTA Board passed resolution 12 regarding the proposed Mt Messenger Bypass Project.

- 1. Would you please provide board paper 2017/08/1178 relating to this resolution, and any other information relating to the resolution.
- 2. Would you also provide any further board papers regarding the proposed Mt Messenger Project.
- 3. Would you please confirm if the board has approved any additional funding for the proposed Mt Messenger Bypass project.
- 4. If there has been additional funding approved, would you please advise what is the revised benefit cost ratio.

In your email to Nicole Rosie, Chief Executive, Waka Kotahi, you requested the following:

We have the project documents filed in support of the resource consent applications and associated hearings, the draft NZTA business case dated August 2017, and the final NZTA business case dated December 2017.

Would you please provide any other information relating to the NZTA decision to recommend and progress Option E, and not progress Option Z (specifically the refined \$150M option Z), including the refinement process following the MCA2 process, the challenge workshop, including documents, correspondence, file notes, text messages.

Would you please update the table below to show actual costs to date as well as expected future costs.

An updated Table 26 does not exist. In the interest of being helpful, the below table has been created showing the actual costs for the periods requested and a forecast total cost.

I have attached copies of the documents in scope of your request. Where a document contains only a small amount of information in relation to the Mt Messenger project I have only provided the relevant pages from the document. As detailed in the document schedule, certain information has been withheld from some of the documents under the following sections of the Act:

- 9(2)(a) to protect the privacy of natural persons.
- 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any department or organisation in the course of their duty.
- 9(2)(j) to enable a Minister of the Crown or any public service agency or organisation holding the information to carry on, without prejudice or disadvantage, negotiations (including commercial and industrial negotiations).
- 9(2)(b)(ii) to protect information where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information.

With respect to the information that has been withheld, I do not consider there are any other factors which would render it desirable, in the public interest, to make the information available.
