Application for the approval of an in-vehicle taxi camera security system for New Zealand

1. General information

This application must be completed by, or on behalf of, any person or organisation who is seeking approval to supply an in-vehicle security camera system for taxis operating in New Zealand (the system).

All such systems must be approved by the Waka Kotahi NZ Transport Agency, prior to installation in any taxi.

Waka Kotahi will acknowledge the receipt of your application and in due course, the outcomes of your application.

Waka Kotahi is not liable for, nor will it contribute to, any costs incurred by you in making this application, or subsequent to any approval or non-approval of this application.

2. Legal references

The legal reference to have systems installed and their minimum requirements is the Land Transport Rule: Operator Licensing 2017.

Applicants should note the relevant sections of the Fair Trading Act 1986 and Consumer Guarantees Act 1993 that apply to the supply of goods and services in New Zealand.

3. Waka Kotahi NZ Transport Agency reference document

Further information you need to know before making an application is contained in the Waka Kotahi publication *Guidelines for suppliers* of in-vehicle security camera systems for taxis in New Zealand. This is available on www.nzta.govt.nz/commercial/passenger/security-cameras

These guidelines include details about how your system can comply with the minimum legal requirements required for camera systems. Waka Kotahi will use these guidelines to evaluate your application.

4. Application fee

A fee of \$118.30 per hour (including GST) is payable to Waka Kotahi for assessing and processing your application. All applications must include payment of this fee equivalent to two (2) hours of time, (\$236.60).

If our processing of your application takes more than two hours we will contact you with an estimate of the extra time (above two hours) that will be required. Any extra time will be charged at our standard fee of \$118.30 per hour. If you do not respond to our contact further processing of your application will stop until we hear from you.

If your application is incomplete we will send it back to you. You then have 60 days to re-submit it. If you elect to withdraw your application or we decline your application having spent no more than two hours assessing it, we will refund an amount equivalent to any unused portion of your application fee, to the nearest hour.

5. Payment details

We'll contact you to arrange a direct debit once the application has been lodged.

6. Instructions for completing this application

The application form must be completed in full. Consideration of your application will be delayed if the information you supply is incomplete.

If you are not based in New Zealand you must provide details of a suitable New Zealand based agent to represent you for both supply and after sale service of the camera system.

Compliance test requirements

The proposed system must be tested and independently certified as complying with the following requirements:

Rule requirements

The camera system must record and securely store images and enable the retrieval of those images for copying, viewing and printing.

- 2 The camera must be designed to be fitted inside a taxi in a position that:
 - (a) is clearly visible to persons seated in the vehicle; and
 - (b) enables it to record the faces of all persons seated in the taxi.
 - (i) (Declaration by the applicant)
 - (ii) (To be confirmed by independent certifier)
- 3 The recorded images must be of a sufficient quality to enable facial identification of all occupants seated in the taxi, in all lighting conditions including complete darkness.

4 The camera system must record images at a rate of at least one image per second.

5 The recorded images must contain a unique and unambiguous identification of the camera, the taxi it belongs to, and accurate time and date information.

- The camera system must be permanently marked with a unique means of identification, applied either by engraving or laser etching. Paper sticker based identification is not acceptable.

- The camera system must be capable of storing at least 7 168 hours of continuous images before it begins to record over those earlier images.

8 The camera system must undertake regular self-testing in order to check that it is recording and storing images.

The camera must have a system status indicator, that is clearly visible to the vehicle's driver and that indicates when the system is operating and when the system has detected that it is not recording or storing images or both.

10 The camera system must create an automatic log of activity including accessing of recorded material and modifying settings.

The recorded images must be protected from unauthorised access.

12 The camera system must not interfere with other electronic devices or systems likely to be found in a taxi and must not be adversely affected by a vehicle's electrical system.

13 The camera system must meet all operating requirements, including storage of images, without the need for any manual processes during normal operation.
