The economic impacts on businesses along the current existing Te Horo Highway. 2. The lack of north bound exit off the expressway before Te Horo. 3. Signage to promote our business 3. The Lack of south bound exit off the expressway after Otaki. The viability of Te Horo and Otaki businesses will be greatly affected if the proposed north Bound exit off the expressway before Te Horo is limited to Peka Peka or further South. The reduction in trade and business opportunity will bring with it major reduction in employment requirements of businesses in Te Horo and directly affect the Otaki community employment prospects. I believe Te Horo Businesses will be directly and severely affected by the lack of proximity and quality of exits off the Expressway currently proposed. I submit for consideration the following- • Incorporate a north bound slip lane exit option before the point the Expressway crosses over the railway line near Manycrest, Te Horo. • Provide high profile signage before interchanges or slip lane exits which promotes Te Horo and Otaki attractions. • Incorporate a southbound exit option off the Expressway on to Gorge road which then links to Addington road and the existing SH1 alignment. • Negotiate with K.C.D.C. to ensure the existing businesses on the old highway will have opportunity to relaxed resource consents in regards to limited access, signage and change of direction and development of our businesses. The advantages I see with this submission are:- • Allowing north bound and south bound travellers the opportunity to leave the expressway and travel through Te Horo and on to Otaki using the existing SH1 alignment will help businesses with more custom and will also be convenient for residents to exit closer to their residence. Emergency services will have quicker access to the Te Horo area off the expressway. • Signage at and before exits will minimise some affects to Te Horo and Otaki businesses and make tourists aware of the opportunities and attractions along the Te Horo-Otaki Strip. While I acknowledge that there will still be a reduction in passing traffic, with reduction in business opportunity, I feel this will help minimise some of the adverse affects (especially employment opportunities) to businesses in Te Horo and Otaki area.
