## **Sustainability Policy**

O Mahurangi Penlink is being delivered in Tāmaki Makaurau. Mana whenua have been able to observe and interpret change within the environment in Tāmaki Makaurau over many generations. This wisdom has been built upon an additional 50,000 years of mātauranga (indigenous knowledge systems) passed down from ancestors.
