

## **New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2020/6**

Pursuant to section 61(3) of the Government Rounding Powers Act 1989, and the Land Transport Rule: Setting of Speed Limits 2017, the NZ Transport Agency hereby makes the following bylaw.

### **Bylaw**

**1. Title and commencement**—This bylaw is the New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2020/6 and will come into force on and from 18 September 2020.

**2. Amendments**—The New Zealand Transport Agency (Speed Limits on State Highways) Bylaw 2010/10\* is hereby amended by:

- Amending line 836 in Schedule 1 to read:

*“Line No.: 836*

*Region: 11*

*SH No.: 1*

*Locality: Glenavy*

*Section of State Highway: From 120m north of White Street to 240m south of Redcliffe Road.*

*Speed Limit (km/h): 70*

*Date revoked: 18/9/2020*

*Speed Limit Rule: Setting of Speed Limits Rule 2017*
