1. Vehicle type

Use this application form if you are applying for a VT 19/951 additional licences combination rates and intend to run it in this combination at all times.

To use these rates you must have a permit issued under the Land Transport Rule: Vehicle Dimensions and Mass 2002 (see Factsheet 13G: High productivity motor vehicles). These rates will enable you to carry weights up to the maximum weight specified in your permit at all times.

2. General

The particulars specified on the *Application for VT 19/951 additional licences combination rates road user charges waiver* will be stored and/or form part of the Motor Vehicle Register. Collection and dissemination of this information is authorised by the Road User Charges Act 2012 and the Land Transport Act 1998. Corresponding information held on other parts of the Land Transport Register may be amended.

Under the Electoral Act 1993, s 263B, the NZ Transport Agency (NZTA) is authorised to release information for data matching purposes to the Electoral Enrolment Centre.
