## Request made under the Official Information Act 1982

Thank you for your email of 23 July 2024 requesting the following information under the Official Information Act 1982 (the Act):

Can I please request the following briefings under the OIA:

- Auckland Ferries

- Funding of Christchurch Public Transport Futures
- Ngongotahā Housing Development Project
- State Highway Pothole Prevention and State Highway Operations indicative allocations broken down by region
- Mt Messenger Bypass
- · EV bus funding and the PT Services
- · Livestock driver fatigue
- Plans to build a cycle path and bus lanes to Kumeū
- Walking and cycling on Ō2NL
- 120km/h speed limits
- Public Attitudes Survey
- Tolling on RoNS
- Breakdown of Waitematā Harbour Connections IBC expenditure

The documents in the attached schedule fall within the scope of your request and are enclosed.

Certain information has been withheld under the following sections of the Act:

- Section 9(2)(a) of the Act to protect the privacy of natural persons.
- Section 9(2)(b)(ii) of the Act to protect information where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information.

Section 9(2)(ba)(i) of the Act to protect information which is subject to an obligation of
confidence or which any person has been or could be compelled to provide under the
authority of any enactment, where the making available of the information would be likely to
prejudice the supply of similar information, or information from the same source, and it is in the
public interest that such information should continue to be supplied.

I am withholding document 8 – MIN-4527 Mt Messenger – in full, under section 9(2)(h) of Act, as the withholding of the information is necessary to maintain legal professional privilege.

I am withholding document 12 – MINO-1093 – Walking and cycling for O2NL – in full, under section 9(2)(g)(i) of the Act to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any public service agency or organisation in the course of their duty.

I am also refusing the release of document 14a under section 18(d) of the Act, as the information is publicly available and can be found at: https://www.nzta.govt.nz/assets/resources/public-attitudes-to-road-safety/Public-attitudes-to-road-safety-Q1-jan-mar-2024.pdf.

With respect to the information that has been withheld, I do not consider there are any other factors which would render it desirable, in the public interest, to make the information available.

Under section 28 of the Act, you have the right to ask the Ombudsman to review my decision to withhold this information and refuse part of this request. The contact details for the Ombudsman can be located at www.ombudsman.parliament.nz.
