

## Wilson Parking New Zealand Limited

## Access to names and addresses held on the Motor Vehicle Register

## **Preamble**

- Wilson Parking New Zealand Limited (WPNZL) requires the names and addresses of persons:
  - i. who are currently registered in respect of a vehicle and who have notified the Registrar that they do not wish their details to be made available under an authorisation given under section 241 of the Land Transport Act 1998 (opted-out), and
  - ii. who are previously registered in respect of a vehicle.
- Applications for the information specified in (1) above may be made through the Waka Kotahi NZ Transport Agency (Waka Kotahi) Motochek system or through a third party supplier of Motor Vehicle Register information if Wilson Parking New Zealand Limited does not subscribe directly to Motochek.
- 3. An application for the information specified in (1) above is Wilson Parking New Zealand Limited's application under section 236 of the Land Transport Act 1998.
- 4. Information disclosed in response to an application specified in (3) above is a disclosure made in accordance with section 237(2)(d) of the Land Transport Act 1998 and is for the purposes of:
  - a. To send notices to the registered person where a vehicle has been parked in a car park enforcement of which is managed by WPNZL (WPNZL car park) in breach of the parking terms and conditions.
  - b. To trace persons registered in respect of motor vehicles where the occupants exit a WPNZL car park without paying for parking, in breach of the parking terms and conditions.

## Conditions

- 5. Wilson Parking New Zealand Limited must, in the first instance, seek to obtain the name and address information via their Section 241 authorisation. Where the information is not returned due to the reasons specified in (1) above, Wilson Parking New Zealand Limited may then perform an additional search via the appropriate level of access (level 2 opted out, or level 3 historic).
- Wilson Parking New Zealand Limited's access to the name and address of persons who are opted-out and who are previously registered in respect of a vehicle is permitted only as is necessary for the purposes specified in (4) above.
- 7. Information disclosed under section 237(2)(d) of the Land Transport Act 1998 may not be used for any other purpose than those specified in (4) above. Any breach of this condition may result in availability of applications made through Motochek or a third party supplier being removed. Requests for personal information outside of these

purposes must be made via the Application for Registered Person Name and Address (MR31) form.

- 8. On request from Waka Kotahi, Wilson Parking New Zealand Limited make available to Waka Kotahi any documents or information confirming compliance with these terms and conditions and/or the specific reason for seeking an individual's name and address. This must include supporting evidence provided in the form of images/footage of the vehicle using the Wilson Parking New Zealand Limited carpark.
- 9. By accessing the name and address of registered persons who have opted-out or who have been previously registered in respect of a vehicle, Wilson Parking New Zealand Limited is agreeing to the terms and conditions.
- This agreement is valid until 30 April 2026 but may be renewed upon application to Waka Kotahi.
