Request made under the Official Information Act 1982

Thank you for your email of 12 July 2024 requesting the following information under the Official Information Act 1982 (the Act):

I am writing to request information under the Official Information Act 1982 regarding LSTA's funding of streetlamp upgrades to LED lighting within the Selwyn District Council and Christchurch City Council areas, as well as the specific locations of Category P lighting where standard lanterns have been replaced with LED luminaires as funded through the LTSA's funding assistance rate (FAR) or equivalent.

Specifically, I would like to know – for the Selwyn District Council and Christchurch City Council areas:

I will respond to each part of your request in turn as follows:

1. The total amount of dollars allocated for the LED street lamp upgrades.

NZ Transport Agency Waka Kotahi (NZTA) contributed:

- \$2,458,868 to the Selwyn District Council between the 2017-18 and 2023-24 financial years; and
- \$18,247,586 to the Christchurch City Council between the 2017-18 and 2021-22 financial years.

Christchurch City Council (CCC) completed its replacement during the 2021-22 financial year.

Based on financial information held by NZTA, Selwyn District Council has delivered approximately 70 percent of its LED programme and will continue delivery through the 2024-25 financial year.

2. The number of luminaires that have been upgraded to LED lighting.

Christchurch City Council has replaced 28,306 luminaires in total. Selwyn District Council has a programme to replace approximately 5,768 luminaires and has completed approximately 70 percent of this programme.

It is important to note that this percentage is based on a financial calculation, due to the more complex (and expensive) "V" category units that were delivered later in the programme.

3. The locations where Category P lighting has been upgraded with LED luminaires.

As separating categories "V" and "P" by location was not required by NZTA from a business case perspective, NZTA does not hold information specific to location specific category "P". I am therefore required to refuse this part of your request under section 18(e) of the Act because the document alleged to contain the information requested does not exist.

We can, however, provide overall locations and LED numbers which are outlined in the following table:
