Request made under the Official Information Act 1982

Thank you for your email of 11 September 2024 requesting the following information under the Official Information Act 1982 (the Act):

any briefings or aides memoire to government ministers about the proposals to toll Te Ahu a Turanga and the Otaki to North of Levin highways, as well as any reports or draft reports about the proposals?

In your email of 19 September 2024, you clarified the timeframe for your request to be between 7 June 2024 and 19 September 2024.

The documents outlined in the appended document schedule fall within the scope of your request and are enclosed.

Please note, certain information is being withheld from Document 1 under the following sections of the Act:

- 9(2)(a) to protect the privacy of natural persons.
- 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank
 expression of opinions by or between or to Ministers of the Crown or members of an
 organisation or officers and employees of any public service agency or organisation in the
 course of their duty.
- 9(2)(h) to maintain legal professional privilege.
- 9(2)(f)(iv) to maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by Ministers of the Crown and officials.
