## Request made under the Official Information Act 1982

Thank you for your email of 13 September 2024 requesting the following information under the Official Information Act 1982 (the Act):

- Tolling Assessment for Te Ahu a Turanga Manawatū-Tararua and any associated reports and advice
- Tolling Assessment for Ōtaki-Levin and any associated reports and advice

The documents in the appended schedule fall within the scope of your request and are enclosed.

Certain information has been withheld under the following sections of the Act:

- Section 9(2)(a) to protect the privacy of natural persons.
- Section 9(2)(f)(iv) which allows for the withholding of information to maintain the constitutional
  conventions for the time being which protect the confidentiality of advice tendered by Ministers
  of the Crown and officials.
- Section 9(2)(g)(i) which allows for the withholding of information to maintain the effective
  conduct of public affairs through the free and frank expression of opinions by or between or to
  Ministers of the Crown or members of an organisation or officers and employees of any public
  service agency or organisation in the course of their duty.
- Section 9(2)(h) to maintain legal privilege.
- Section 9(2)(b)(ii) to protect information where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information.
- Section 9(2)(j) to enable a Minister of the Crown or any public service agency or organisation
  holding the information to carry on, without prejudice or disadvantage, negotiations (including
  commercial and industrial negotiations).

With respect to the information that has been withheld, I do not consider there are any other factors which would render it desirable, in the public interest, to make the information available.

Please note, Document 15 in the document schedule is withheld in full under section 9(2)(f)(iv).

Documents 17, 20, 22 and 23 are refused under section 18(d) of the Act as they are publicly available.
