Request made under the Official Information Act 1982

Thank you for your email of 13 September 2024 requesting the following information under the Official Information Act 1982 (the Act):

Copies of any the Minister's reports, documents, minutes, briefing notes, memoranda, correspondence, legal advice, aide memoires, texts or emails, both internal and external mentioning the introduction of tolls on the Te Ahu a Turanga – Manawatū Tararua Highway– dated up to May 2024. This includes drafts, appendices and attachments.

The information sought in this request is to be used as part of reporting about the highway.

In our subsequent emails with you seeking clarification, on 14 October 2024, you specified that you wanted to receive the "200 emails" between 1 January 2019 and 31 May 2024 that were potentially in scope of your request. A review of emails that were potentially in scope of your request was subsequently undertaken, and the following documents in the appended document schedule fall within the scope of your request and are enclosed.

Certain information has been withheld under the following sections of the Act:

- Section 9(2)(a) to protect the privacy of natural persons;
- Section 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank
 expression of opinions by or between or to Ministers of the Crown or members of an
 organisation or officers and employees of any department or organisation in the course of their
 duty; and
- Section 9(2)(h) to maintain legal professional privilege.

With respect to the information that has been withheld, I do not consider there are any other factors which would render it desirable, in the public interest, to make the information available.

Under section 28 of the Act, you have the right to ask the Ombudsman to review my decision to withhold this information. The contact details for the Ombudsman can be located at www.ombudsman.parliament.nz.
