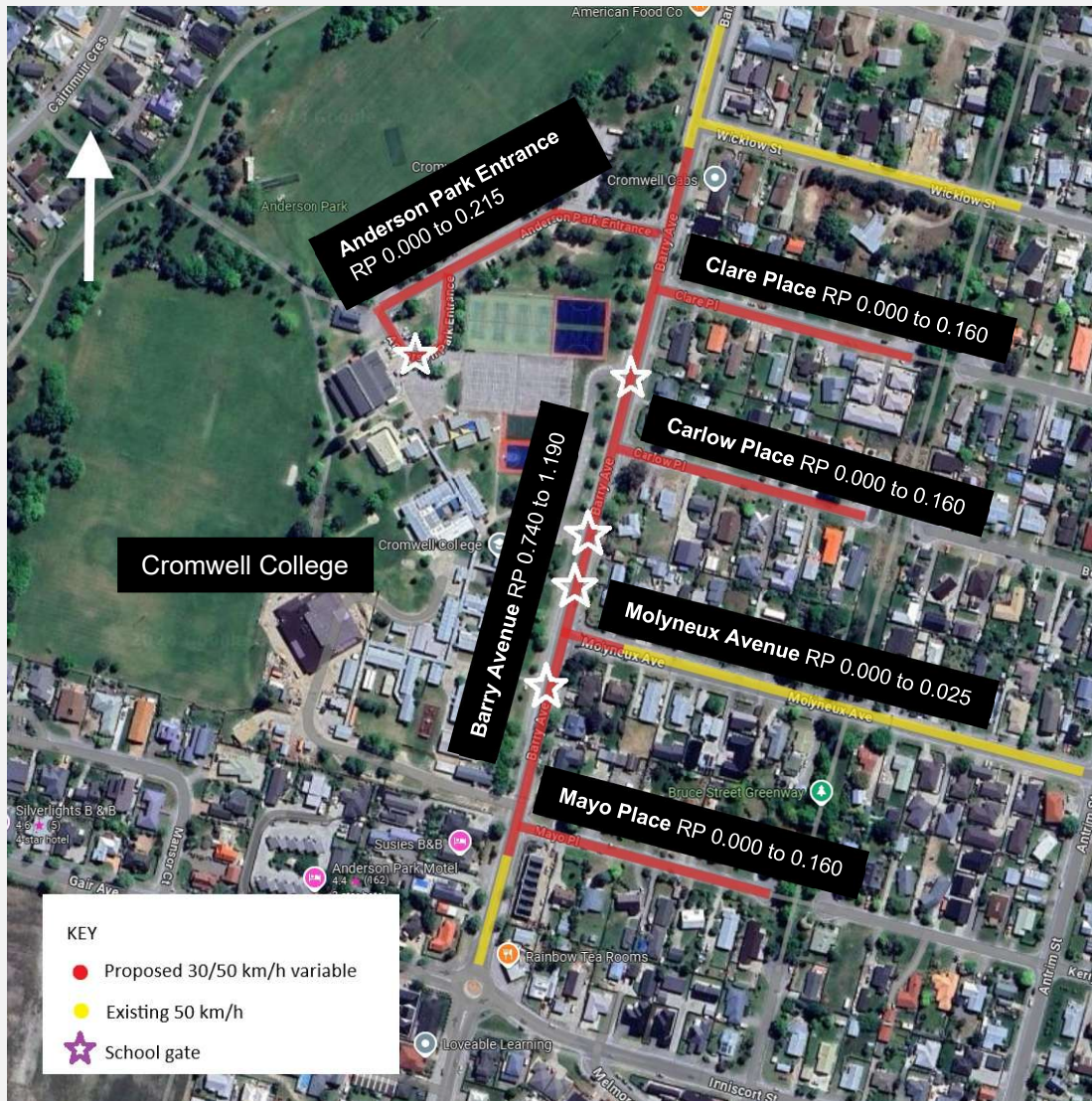

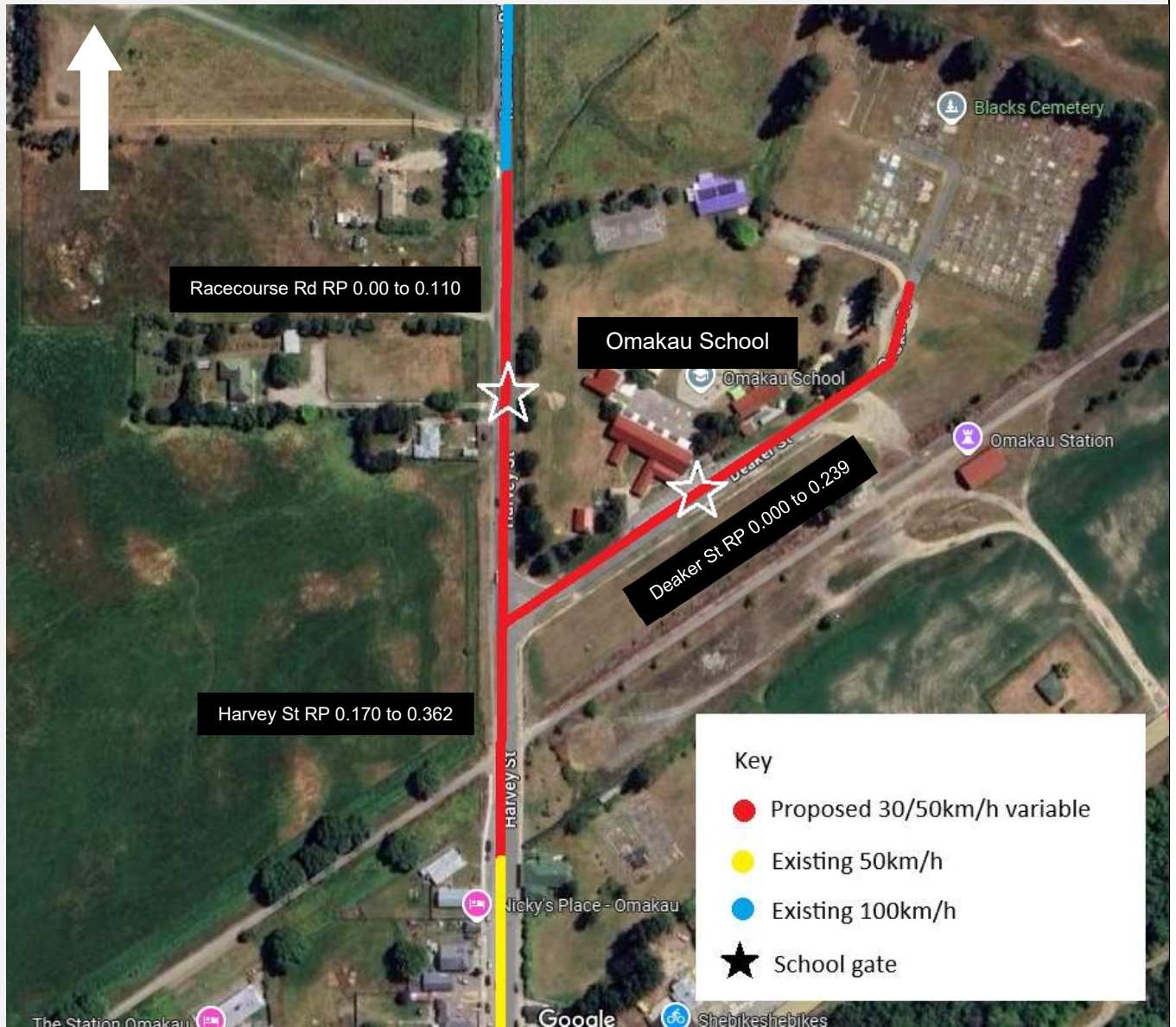

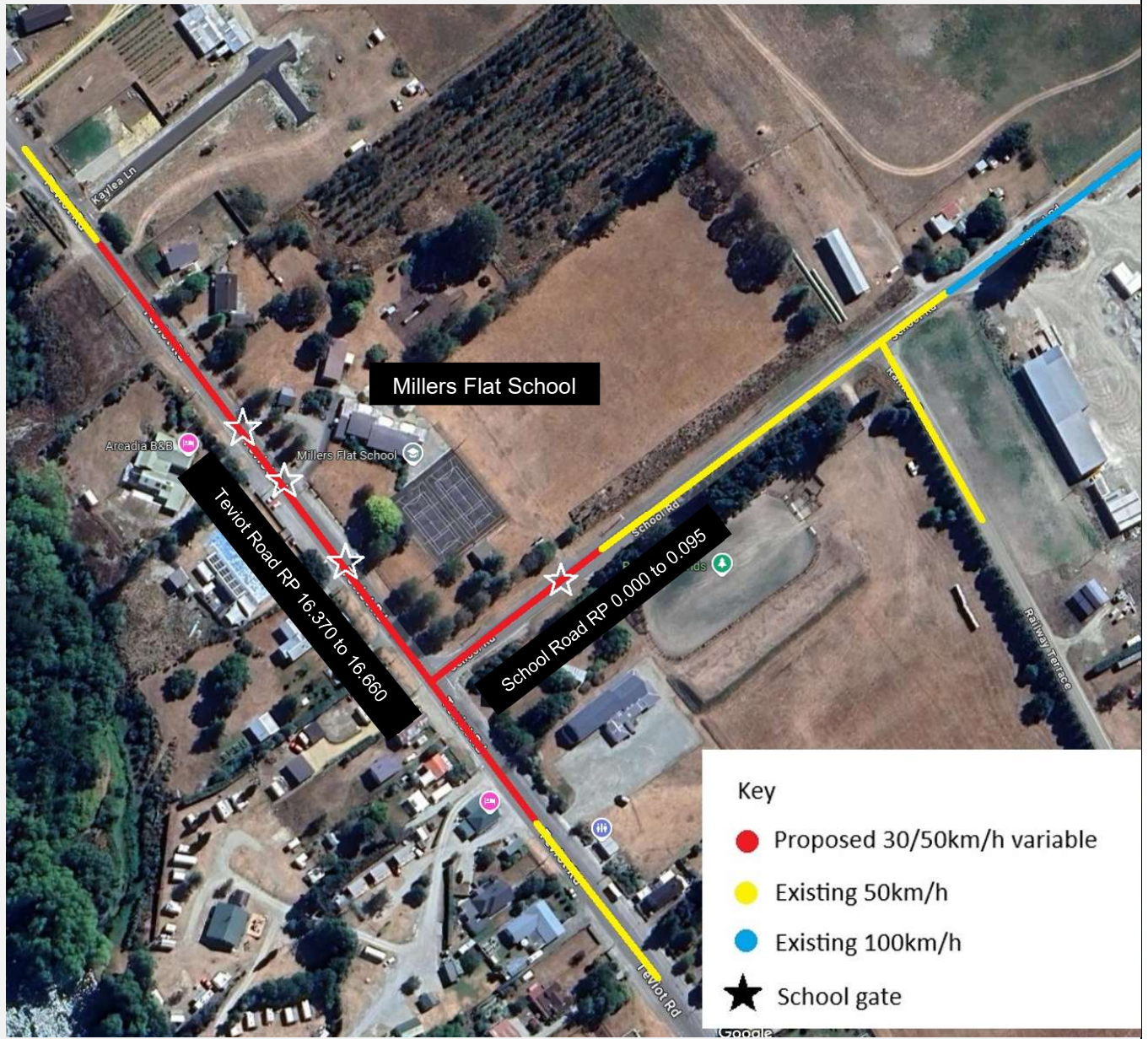
Proposed Changes to Clyde Primary School Speed Zone

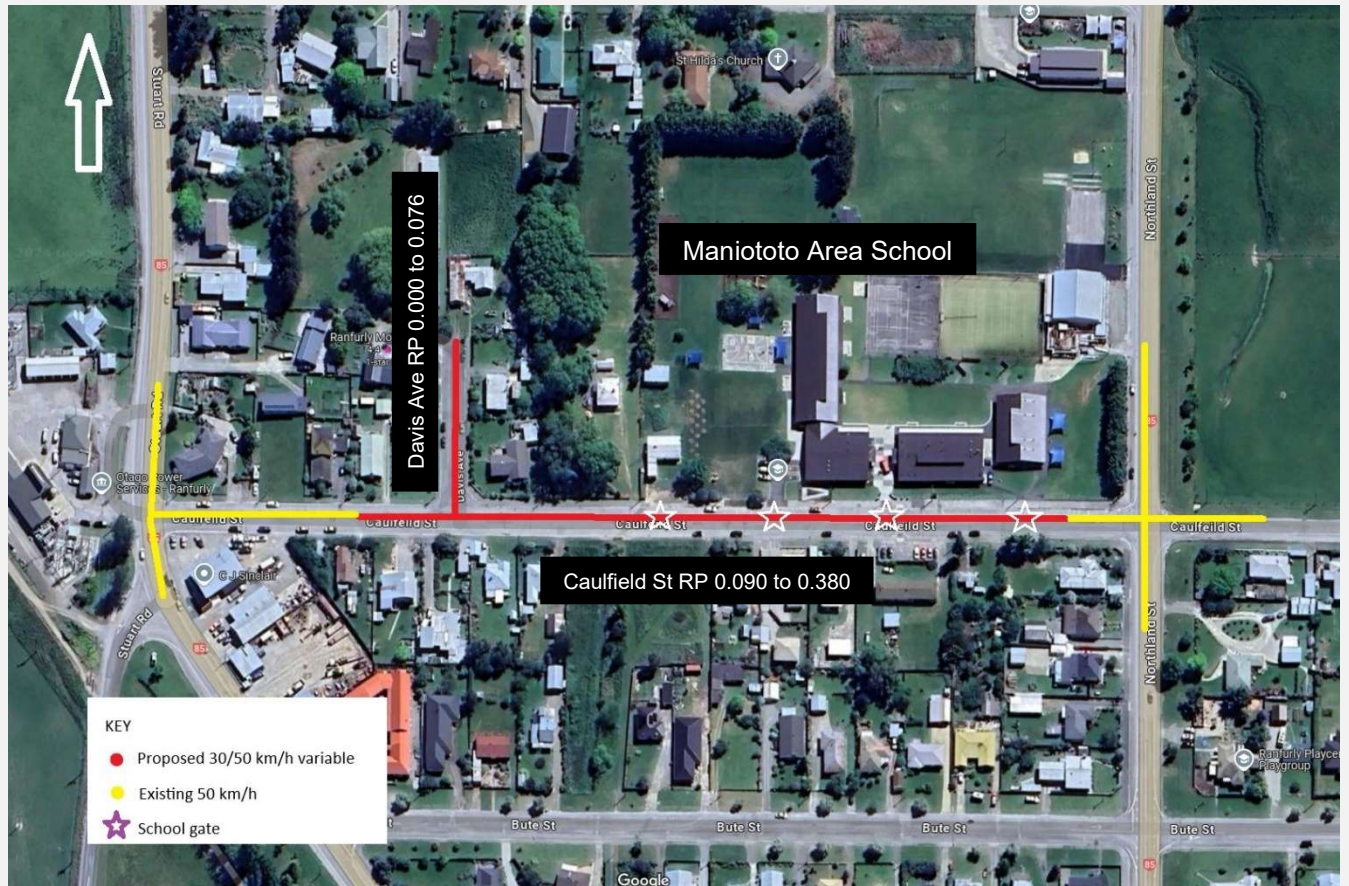
