1	Individual	SH Waihola	Yes I think it should be lowered to 50km/h as the small town has increased in size and in summer is quite busy. With drivers unsure of where they are going can be dangerous at times.
2	Individual	SH Waihola	The proposed speed reduction through Waihola is essential and needs to be implemented as soon as possible . I travel through this town on a reasonably regular basis and find that the speed limit is set far too high . Vehicles parked on both sides of SH1 reduces the width of the carriageway and there is often a large number of pedestrians crossing the road or visit the various shops and tea rooms and the current speed limit is putting these people at extreme risk . Vehicles pulling back out into the traffic with the current speed limit is also another factor and there are a number of recorded injury crashes which have happened. Another issue Is with vehicles turning right to the hotel and dairy car park as well as going to the lakeside. This is particularly common during holidays and fine weather and at weekends when people go to the lakeside .A number of serious road crashes including fatalities have also happened on this stretch of road due to a number of factors including excessive speed and inattention .I am fully in support of reducing the speed on SH 1 to 50kph as at present the 70kph limit is far too high for the amount of traffic which passes through the town .
3	Individual	SH Waihola	The Clutha Gold Cycle Trail is being extended from Lawrence to Waihola. Once open there will be many cyclists around Waihola. Reducing the speed limit will make cycling around Waihola. Signage advising motorists to be aware of cyclists would be good
4	Individual	SH1 Waihola	It is imperative that the speed through Waihola township is reduced. It is very difficult to cross Highway 1 safely because of the speed limit of 70km, and it is doubtful that people keep to the speed limit.

Often I feel like the meat in the sandwich, with trucks coming toward me and a truck coming from behind. People stopping for coffee, fish and chips and ice cream
14	Individual	SH1 Waihola	A 50kmh speed limit will make it so much safer for our children. There is sometimes so much traffic it is hard to cross, as the traffic is going so fast at 70ph. I have seen a lot of near misses. Because of the current speed limit, a lot of times my children can't cross the road to get to their school bus. My daughter has just got her driver's license. but is too nervous to drive across the main road due to oncoming traffic travelling too fast.

15	Individual	SH1 Waihola	I think there should be a zebra crossing on the main road. I think there should be a zebra crossing on the main road.
16	Individual	SH1 Waihola	We think this is a good decision(50k) but could there be a 70km/h lead in section before the 50km at both ends? This would allow a slowing period which we feel would increase safety. Installing a pedestrian crossing on the highway through the middle of Waihola would be helpful.
17	Individual	SH1 Waihola	It can be quite difficult and dangerous visiting clients on the main highway as both the entry and exit to Waihola have blind corners at the speed transition points when traffic is supposed to be slowing down to drive through Waihola. It is often hard to pull off the main highway and set across the road when turning right. I have personally had and witnessed several near misses. My submission is for reducing the speed limit to 50km/h.
18	Individual	SH1 Waihola	Logging trucks would never be able to stop nor others. I have had a close encounter walking at area outside Hotel. They don't slow down before the 70k sign therefore going down into Waihola they are still travelling at a high speed.

			Engine breaks signs are required and early speed limit signs similar to those in Allanton. Reducing speed through Waihola will make a difference.
34	Individual	SH1 Waihola	The main attraction/recreation for the town is the lake and playground with this being on the opposite side to the township it would be best for the community especially the children and elders if the speed was reduced to 50km/h. There are also a huge number of near miss accidents, as well as actual crashes, some unreported. The NPD service station - when large tankers come to refuel the station, it blocks off the side street which is very dangerous especially to traffic turning off SH1. This can cause vehicles to stop suddenly on SH1, where a lowered speed limit would reduce the chances for accidents - especially rear-ending. There is also a lot of local turning traffic on SH1 as mailboxes for all residents are on the west side of the road.
35	Individual	SH1 Waihola	A 70km/h speed zone leading up to the 50km/h speed limit both north and south of the township. Waihola also needs a pedestrian crossing.

If the speed limit is lowered this will become more of a nuisance as the trucks will have brake for longer (and probably harder) in order to drop their speed to the 50km/h limit. the noise from more frequent and persistent engine braking will affect our sleep even more than it does now. Please exact signs advising no engine braking for trucks next 1 Km along with the new speed advisory signs.
43	Individual	SH1 Waihola	We agree to lower the speed limit to 50km/h.

48	Individual	SH1 Waihola	I believe you should consider adding speed AND speed averaging cameras at each end of the restriction area so that the average speed of every vehicle passing through is calculated. There is good evidence of their effectiveness - see fall in A9 accident rate in Scotland from Stirling to Inverness (despite increased traffic volumes) (https://www.pressandjournal.co.uk/fp/news/highlands/1457907/deaths-and-crashes-down-since-average-speed-cameras-introduced/) and study from LSE "Speed cameras have been shown to be effective at reducing the number of accidents and road deaths according to the results of a new study conducted at the London School of Economics and Political Science (LSE). From 1992 to 2016, speed cameras reduced accidents by between 17 to 39 per cent and fatalities by between 58 to 68 per cent within 500 metres of the cameras." In addition to reducing accident rates, the risk of serious injury and death in the accident is reduced if the speed is lower.
49	Individual	SH1 Waihola	This is an extremely busy road and for safety reasons I think that it is extremely important that the speed limit be reduced to 50km/h.
50	Individual	SH1 Waihola	I believe traffic needs variable speed along the length of the highway in Waihola township. I agree with a 50km/h limit. Request that the approach from both north and south of Waihola also is set at 70km/hr for some distance to allow streams of traffic to slow down. 70-80km/hr is plenty when approaching the township, due to terrain and mixture of traffic - milk tankers, sheep & logging trucks/fertiliser etc, mixed in with multitudes of small cars, SUV's, buses, camper vans, even slow-moving farm equipment at times. I've observed seasonal variation in movement of traffic, but overall, people are inclined to be impatient of slowing to accommodate different types of traffic sharing the road, so I urge you to consider progressing the speed down and up on arrival and departure from the lake area.

57	Individual	SH1 Waihola	A 70km/h speed limit is way too fast! Two of my cats got hit by cars! One died and the other had to get its leg amputated! Imagine going through that pain! And I bet they would have survived if it weren't for that speed limit! Kids live on the main road and its full of shops! If you lower the speed limit to 50km/h you can legally put a zebra crossing, it works out for all of us! Imagine you or your kid crossing a main road with cars zooming past at 70km/h! It's Completely UNSAFE! Lake Waihola is also a huge tourist attraction!
58	Individual	SH1 Waihola	I completely support this change. We crossing the main road with a speed limit of 70km/h is unsafe for adults let alone children.
59	Individual	SH1 Waihola	Since December, I've seen at least three accidents and regularly see near misses on this stretch of road. I strongly agree that the limit should be brought down to 50km/h. Too many people are pulling out of and into the local eateries.

85	Individual	SH1 Waihola	I support the proposed reduction in speed limit by 20km/h in Waihola. The town is a busy tourist and water sports village that is becoming busier each year. There is a popular camp ground as well as a growing number of elderly people. Shops and amenities are on both sides of the road making it essential that people must cross. Lowering the speed limit will make this safer. NZTA should seriously consider a pedestrian crossing controlled by lights as well as the speed reduction. A minimum measure is to set up a median island so that pedestrians can cross part of the road at a time.
86	Individual	SH1 Waihola	Waihola is and has been for some time a popular alternative retirement destination. With the present speed limit, it is most difficult to safely cross SH1 without a car or truck, being suddenly upon the person crossing the road. It is equally difficult when crossing the road with small children. Telling children to cross quickly and carefully does not always equate well with crossing SH1 anywhere in Waihola. Especially when people seldom actually hit the required 70 km per hr.
87	Individual	SH1 Waihola	No, the sooner the better for the reduced speed. Thanks
88	Individual	SH1 Waihola	Why do you have to re-purpose a highway? Ask the local council to purchase the land to the side of the highway and build a suburban road for residents and business such that they can retain access to their properties. Or have them install proper barriered footpaths to the sides of the highway, once again being their responsibility. The council likely consented all the neighbouring activity too, it is for the local council to pay for and resolve. Investigating how the highway could be returned to an open road speed should be NZTA priority here.
89	Individual	SH1 Waihola	I have never had a problem with the 70km speed limit in Waihola. Now I see the problem very well. Because as it is in life its not relevant until it is your problem. Your family. At risk. In danger. Pulling out onto the main street is a nightmare. each time it feels like a gamble on whether we'll make it. At this point in the road most vehicles are speeding up in anticipation for the 100km limit. That's if they've slowed down much to begin with. We pull out of a hard to see drive way. Sometimes it takes three or so attempts before we can finally pull out without another vehicle already upon us. Especially difficult when we have a trailer load behind which is often the case. Milk tankers, log trucks, a steady stream of traffic coming along accelerating around a blind corner as we attempt to re enter the road. The point isn't even the 70km limit. It's the fact that most don't even slow to that. If the speed is lowered to 50km maybe most will decrease theirs to below 70k. Making it safer for the community, children walking to and from school, the elderly and the many whom travel to Waihola as a holiday/summer destination filling the streets and needing the peace of mind of being able to cross the road for an ice cream without being run down.
