1	Individual	Increasing traffic volumes New cycleway and access to Recreation Centre Increasing number of houses - new subdivision Busy at Paines Ford Access to the Hospital
2	Individual	Consider the new cycleway, increasing number of houses on this part of the highway due to the new subdivision and access to the new Recreation Centre facility
3	Individual	My grandchildren regularly cross sh60 from where they live on dodson Road to walk or cycle to central takaka school, also to go to the rec centre. The traffic is way too fast for them to do this safely on their own. The speed limit should be at least 80k mh, preferably 60km per hour as it is leaving takaka for pohara.
4	Individual	Road passes by the Medical Centre, where elderly and frail people often leave to turn right into Takaka. This is problematic especially if the traffic doing 100 km/hr.
5	Individual	If the mean speed is only just over 80, this change fails to fully address the issue of safety. It should be a speed limit of 60km/h on this stretch to significantly reduce speeds.
6	Individual	We agree with the proposal to decrease the speed limit from Paines Ford to Takaka township from 100km to 80kmph on a permanent basis. While the process is being addressed we consider it is an opportune time to sort out the confused exits and entrances at the Recreation Park, Park Avenue and Dodsons Road. Many different sports and meetings take place at the Recreation ground and it has become very popular since the development of the Recreation Centre with at least some 26 different sporting activities. Of late the use of this entrance and exit has increased many times over. As for Park Avenue, a new subdivision of 25 sections is almost complete with 18 sections already sold off the plan. This could increase the feed of the intersection by around 200 passes a day. Also Dodsons Road feeds into this intersection. The new cycleway will also increase the busyness of the intersection. We feel this would be a golden opportunity to sort the issues at the intersection making it safer now than after there is an accident and someone is maimed. Although we are not roading engineers our suggestion would be some type of Round-about.
7	Individual	Please lower the speed limit to 80 km/h because: - it will reduce harm when accidents happen - it will make travelling on and alongside SH60 safer and more pleasant (think of cyclists, mobility scooter users, pedestrians etc) - it will reduce noise for the local residents and road users - it will reduce carbon emissions due to lower speed (maybe not very much, but everything helps) - it will be more consistent in the speed transition: from 100 km/h (SH60 south of Paines Ford) to 80km/h to 50 km/h (Takaka) instead of 100km/h - 80km/h - 100 km/h - 50km/h Please help us in reducing speed !!! As the policeman says: less speed - less harm !
8	Individual	I totally agree; the change to 80 km/h throughout will be much safer and better than the seasonal change (easy to miss!). It is also unnecessarily complicated to change back to 100 km/h for the last km into Takaka.

12	Individual	Thank you for the opportunity to reduce the speed limit along this road. I personally travel it several times a day for work and it is very scary. I would be keen to see it reduced to 70 with the new cycleway now running alongside. I also think that there needs to be much better road signage prior to the bridge, stating how far Takaka township. There are many large vehicles like Campervans who use the GPS and they are sent down Central Takaka road, as this shows the shortest route to Pohara. This causes a huge problem on the main road with vehicles slowing quickly and turning on this fast flowing road. These campervans do not cross the road quickly. Many people get to the beach and have no idea there is a town. I would like to see some real consideration along with this for the signage to be more relevant, showing the Community Health Centre, the Rec Park and Takaka township alongside the new 80 km speed limit. These are 3 things that visitors may be looking for and do not know where they are and having a much slower flowing part of the road would be much safer for everyone.

14 15	Individual Individual	I support the proposed permanent 80km speed restriction from Paines Ford through to Takaka. This area has high pedestrian and cyclist use during summer, there is the community health centre, turn off to the school and Pohara back road, popular recreation reserve, AMP show in summer, turnoff to Anatoki Salmon. Making a permanent 80k limit through this area does make sense and traffic is naturally slowing upon arrival shortly in Takaka. I do not support the proposed 80km limit from Upper Takaka to Paines Ford. There are many long safe straights and gradual corners through this area. This road is no different to many other rural highway areas and a 100km limit is appropriate. I do not support lowering the limit in Upper Takaka to 60km. This road area is very wide with large road areas and a wide grass verge, there is excellent visibility, a safe median area for any turning traffic, and in my
		experience little traffic from houses in the area.

17	Golden Bay Community Board	The Golden Bay Community Board support the proposed speed reduction between Takaka and Paines Ford. The number of active transport users have been increasing along this section of SH60, and the establishment of a new shared path with only increase with a new subdivision in development, the Shared Recreation Facility, the Golden Bay Community Heath Centre and the Paines Ford recreational area all located along this stretch of SH60. Research has shown that a reduction of speed by 20km/hr reduces the risk of serious harm or injury or death by 50%. For this reason alone the Golden Bay Community Board are firmly in support of the proposed speed reduction.
18	Individual	First of all, it is unnecessary to reduce the speed along there. I drive that part of the road at least once a week and have never had a problem as long as the other drivers are total retards. In stead of reducing the speed of the road, maybe we should be increasing the knowledge of the drivers. Giving them better understanding and know how of how to drive would make the road much safer. However, you'll never do that because that'll be expensive. You'll always do the cheap option.
19	Individual	I support the proposal. There are several intersections several are significant particularly the one onto Central Takaka rd, but also the Kotinga crn and the new sub division going in Park ave. I believe 100 km is too fast, and drive it at 80 km/hrs already.
20	Individual	I support the change to 80kph. Big increase in pedestrian numbers, cyclists and vehicles in recent years due to development of Paines Ford tourism and GBCH facility on Central Takaka Rd
21	Individual	We fully support your proposal. With the amount of traffic from the GB Hospital and Community Health Centre joining SH60 at a somewhat tricky intersection the speed reduction on SH60 would significantly reduce the chances of a fatal accident. Additionally, there is the Golden Bay Recreation Park Centre, the traffic from which also joins SH60 between Paynes Ford and Takaka.
22	Individual	The increased accident rate when people are in a hurry to get somewhere and the vehicles in front are traveling considerably below the speed limit. Even though they shouldn't but it does happens drivers frustration builds up and they pass the slow vehicles when it may not be safe to do so. On this piece of road it is quite safe to travel most of it at 100km/h but even with the speed limit at 100km/h there are often vehicles traveling at 80km/h or less so if the speed limit is reduced to 80 then it is likely that there will be a number of vehicles traveling at even less than 80km/h. Golden bay has a lot of people who want to live life at a slower pace and they are trying to force their lifestyle choice on everyone but there are many people probably a majority that want to live a normal life and they are often in a hurry to get more done in a day and travelling at 80km/h on a straight piece of road in a modern vehicle which can travel safely at 100km/h is just frustrating.

28	Individual	Submission to the NZ Transport Authority on the need for a reduction in the speed limit from Paine's Ford Bridge to Takaka, Golden Bay As residents and property owner on the stretch of road under consideration (State Highway 60 from the Paine's Ford Bridge to Takaka) I feel strongly that the current speed limit of 100kph is excessive and dangerous. I request therefore that the speed limit on this stretch be reduced to at least 70 kph, if not further. The reasons we have for this request on this section of Highway 60 are as follows – 1. The significant number of residential properties feeding onto the highway on this stretch. 2. The presence of both a busy campground and popular swimming hole, the local Community Health facility (GBCH) and an upgraded Recreation Centre all fronting onto the highway. 3. The contour of the road – significant bends, often with poor visibility. 4. 6 active subsidiary streets and roads feeding onto the highway over this stretch 5. A narrow bridge 6. Heavy traffic from Takaka going to and from the GBCH through a busy intersection. 7. We now have a cycleway from Paines Ford into Takaka. This is a valued upgrade for our community and will be well used. 8. Changes of land use over the years with proposed new subdivision needing access to the highway As a resident on this section of highway for nearly 30 years we have seen many changes to the volumes of traffic (especially tourism) and witnessed many near accidents when accessing our driveway. Several major accidents have occurred near our entrance gate, largely due to the high speed allowed on this road. This situation is past time for change. The limit should be 70 or ideally down to 60 kph on this stretch of road.

You can't see cars coming from Upper Takaka driving towards Takaka (even at a speech of 80 km/h) and I would recommend a roundabout. 64	The Central Takaka School Board of Trustees	The Central Takaka School Board of Trustees is writing in support of a reduction in speed from 100/km/hr to 80km/hr between Paines Ford bridge and Takaka township. Central Takaka School is located on Central Takaka Rd apporx. 500m from the intersection of SH60 and Central Takaka Rd - known as "Hospital corner". Students', aged between 5 and 11 years, residnts on Dobson's Rd need to cross SH60 at the above intersection twice a day. The timing of this coincides, particularly in the morning, with higher than normal traffic levels due to the number of frieght companies and tradespeople arriving or leaving the area. As this traffic is primarily from outside of the Bay drivers are usually unaware of the school's location and that children may be present attenpting to cross the state highway. Although, we accept the speed reduction will not completely resolve this problem, it would go some way to reducing the the risk to our students and their families.
65	Individual	Formal Proposal September 2020 SH 60: Palnes Ford Bridge to Takaka. Support for the proposal of NZTA to reduce the speed limit from 100km/hr (to 80km/hr. Part of this stretch of the highway has a holiday speed limit of 80 km/hr (from 21 Dec) which reverts to 100 km/hr between January-March. The reduced holiday speed limit acknowledges the risks, but fells for recognize they exist year round. 100 km/hr is too fast for this section. NZTA's mega maps modelling has the safe and appropriate speed as 80km/hr. Increased traffic volume due to recreation and tourism In the last few years in Golden Bay, as elsewhere in the country, traffic due to recreation and tourism has markedly increased. Extending well beyond the summer months people are using the side of the highway just after Palnes Fords Bridge for parking while they access the reserve (popular for walking and rock climbing) and swimming hole at the Takaka river, probably the most popular swimming hole in Golden Bay. Increased traffic volume due Land use changes Increased traffic volume due Land use changes There have been several significant land use changes adjacent to this stretch of SH60 that requires the speed limit to be reduced permanently to reflect these changes. Golden Bay's health services are now integrated into one building; the hospital, medical centre and the rest home now exist together in the one premises at the intersection of SH60. Dodsons rd and Central Takaka rd. Having the medical centre there particularly has increased traffic turning at the intersection. As there is no footpath or cycle path to the facility from the township people riding mobility socolers creates a potentially hazardous situation. A large multi purpose recreation centre recently built at Park Avenue is accessed from SH60. This facility has been heavily promoted and includes a huge range of community recreation from outdoor and indoor sports and activities such as Bridge; A child's plagnized in the stream of the proper situation. 66	Individual	I wish to provide formal feedback on the proposal to reduce the speed limit between Paines Ford and Takaka to 80 k/h. I am firmly in favour of this proposal. I provided similar feedback to the informal consultation in November 2019 and on review I believe it is all still relevant. Please consider the following factors when making your decision. I have lived at Paines Ford for 25 years. In this time: a) the traffic has got heavier, b) there are many more people using the Paines Ford reserve (notably rock climbers), c) the swimming hole in Takaka River downstream of the Paines Ford bridge has become very popular, d) Hangdog Campground has been established, e) the tourist season has expanded from the traditional 'Xmas fortnight' to the 6 months from Labour Day to Easter, f) the doctors' surgery and old people's home have been moved to Central Takaka, g) the rec-park has been expanded, n) several new houses have been built along the highway, and another subdivision has been approved near Park Avenue. All these developments mean there are more people whose use of SH60 puts them at risk from high speed traffic. When at home, I frequently hear the signs of a near miss - engine brakes, air horns etc - and later when I am at the highway I see another set of black tyre marks. I have also witnessed several crashes and more near misses than I can count. My observation from living nearby is that the basic problem is high speed traffic does not mix well with slow local traffic, pedestrians and parking. As to time and economic cost, the distance from Paines Ford Bridge to the 50-sign at the start of Takaka is a little under 3km. It takes 25 seconds more to travel it at 80 k/h than at 90 k/h. I consider these are trivial amounts of time. I contrast them with the hours, days and months of people's time that are used up when there is a crash: the injured; the surgeons; the rescue chopper; physiotherapists, family members and so-on. I have attached two photographs. The first is of a man who I often see riding his mobility s
67	Individual	I have lived here for 26 years. I have seen many near misses over the years and a reduced speed limit would reduce the risk considerably. I live at 1901 Takaka Valley Highway. When I want to turn out of my property towards Takaka, I have found sometimes that drivers are overtaking on my side of the road towards Paines Ford bridge at fully 100 km/h or more. Because of the bend in the road it is hard to see them in time. I think it would make it safer if this section of road would be marked as no overtaking. Please consider installing a speed camera. I strongly support the proposal to make the speed limit 80 km/h from Paines Ford Bridge to Takaka.
68	Individual	I would like to record my strong support for the proposal to reduce the speed to 80 km/h on SH60 from Paines Ford to 270 m south of Motupipi Street. This section of road is not safe and has a history of crashes—as already partially recognized by the temporary speed limit of 80 km/h over summer for part of the route. With the development of the hospital and the Recreation Centre the 80 km/h speed limit is more appropriate than ever. I hope that this can be done sooner than later.

70	Key stakeholder	Thank you for your GB Weekly invitation to participate in your safe speed review. We would like to see the stretch of Highway from Paines Ford Bridge to at least White Rock Engineering 2049 Takaka Highway reduced to 60km. We are residents and properly owners of 1909 Takaka Valley Highway which is on the stretch of road under consultation. My companion & I each have a car which feeds directly onto SH60 and due to the high speed of the traffic, including big roaring trucks, exiting in particular is very nerve racking. Across the road from our place is Quarry Farm Community and neighbouring 'Hang Dog' camp grounds. Both places have a constant flow of vehicles, bicycles and walkers exiting and entering directly onto the highway. Although it's a Highway the width of the road is narrow and now it's being shared by the newly constructed cycle way too. This in turn makes our section of the road even more precarious because so many more people will be using it to go to and from Paines Ford and the swimming holes. During our nearly 20 years of residence on this section of highway there have been several major accidents largely due to the high speed allowed on this road. Within the area we are recommending a 60k limit, are the new local Community Health facility on Central Takaka Road, the upgraded Takaka Showgrounds Recreation Centre and the new sub division on Park Avenue. There is also Central Takaka Road Primary School rededing onto Takaka Valley Highway from close by. With the constant flow of traffic there is also the ever increasing noise factor. This I know is already a problem for the elderly residents of the Community Health Centre who really deserve a peaceful quiet environment. There are several units in close proximity of the road who in particular suffer the undesirable noise and surges from the braking trucks too. The gardens where hospital residents in general rest, are also affected. I find it incongruous that there are roads in Takaka which already have the adequate 60k speed limit such as the
71	Individual	I support lowering the speed limit from 100 to 80km/hour for the section from Takaka to Paines Ford bridge as outlined in the proposal. I would not support lowering the speed limit beyond this section to Upper Takaka. The small number of dwellings and cyclists would not warrant that change and it would negatively impact on commercial vehicles driving schedules. S 9(2)(a)

Nelson Mariborough Health (Nelson Mariborough Health Board) (NMH) is a key organisation involved in the health and wellbeing of the people within Te Tau Ihu. NMH appreciates the opportunity to comment from a public health perspective on the Waka Kotahi's consultation on SH6 Upper Takaka to Takaka. 2. NMH makes this submission in recognition of it's responsibilities to improve, promote and protect the health of people and communities under the New Zealand Public Health and Disability Act 2000 and the Health Act 1956. General Support 3. NMH continues to advocate that the legal speed limit is based on the road type rather than having the same open road speed limit for all roads. 4. Road crashes and injuries have major impact on people and communities. The average 2018 social cost is estimated at \$5.07 million per fatal crash. \$525.600 per serious crash, \$29,900 per minor crash, this includes estimated cost of loss of ifie and life quality, loss of output, medical cost, properly damage costs and legal and court costs incurred. 5. Speed affects the likelihood and the severity of it's consequences. Small reductions in impact speeds greatly increase the chances of surviving a crash. World Health Organisation states that an increase of 1 km/h in mean vehicle speed results in an increase of 4-5% of fatal crashes. The Ministry of Transport's Safer Journey report states that there is a 10% probability for death for car drivers in frontal impact collisions travelling at 70km limit compared with 30% probability for car drivers travelling at 95km/h and 50% probability for drivers travelling at 105km/h. 6. NMH is supportive of the objectives of the Ministry of Transport's Safer Journey Strategy to improve the roads so that ease type of road has recognisable and distinctive set of self-explaining features such as signage, lane width, road markings and speed limits. This will encourage people to travel at speeds that best fit the design and function of the road. 7. Speed also has adverse on levels of environment
78	Individual	Your proposals aren't ambitious enough and will achieve little. One way streets/roads have been proven internationally to significantly improve safety and reduce accidents. Propose vehicles departing Takaka Township turn at hospital corner and take East Takaka route out of Golden Bay. This is a very scenic route through beautiful farm land and attractive bush. Unsealed part of route would require sealing and some minor widening of road. Large semi and trailer units have successfully negotiated this route in the past. With no traffic coming in the opposite direction and some minor road widening, trucks would have no more difficulty that they do on Takaka Hill. Speed limits as determined by NZ Transport Agency. Vehicles arriving into Golden would continue to use current route with speed limit reducing to 80km/h at Paines Ford Bridge. I acknowledge this plan would have same impact on the people living along these routes, but the numbers involved are small and the benefits massive. Peoples lives matter. Be brave and make the right decision. I'm sure Jacinda will print some more money to fund this proposal if you promote the merits of this plan adequately.

We also submit to reducing the speed limit to 40km/hr from the commencement of Commercial Street to 100 metres past the intersection with Reilly Street. We also note from your presentation of "what we have heard" that your emphasis of concern about speed limits on the balance of SH60 Upper Takaka to Takaka other than over what you propose is not borne out by our review of the comments posted on your map at the road. The vast majority of comments were for maintaining the current situation with the majority requesting improvements to the infrastructure - ONE LANE BRIDGES being a focus.
91	Individual	I think that is a good idea. When coming out of the Central Takaka Road onto the main highway by the hospital, cars travelling at 100mph appear very quickly from around the bend. I think the speed limit should be 90kmp.

109	Kitchen Garden for GBCH	Submission to the NZ Transport Authority on the need for a reduction in the speed limit from Paine's Ford Bridge to Takaka, Golden Bay. Dear NZTA. The Gardeners and Volunteers who work within a few metres of the stretch of highway under consideration (being workers in the vegetable gardens supplying the Golden Bay Hospital Kitchens) feel strongly that the current speed limit of 100kph is excessive and dangerous. Our workplace runs close against the highway and day to day we are constantly witness to reckless driving behaviour due to excessive speed. We have had a car crash through our garden fence onto our gardens. This would probably not have happened if the speed limit had been more reasonable. The Hospital intersection is a busy one and feeds direct onto the 100kph highway - as do a number of other small roads between the Paine's Ford Bridge and Takaka Township. The built-up infrastructure along this stretch of highway has changed over the years - the new Golden Bay Community Health, Recreation Grounds, Campground and popular swimming hole - and now many more cars than in the past feed onto the highway from private properties or subsidiary roads. 110	Individual	I live next to \$9(2)(a), in the summer months 40 cars a night park up, that is many entries & exits. Then the D.O.C reserve 'once again' many cars using Paines Ford in summer. Two neighbours away is a contracting business with haymaking, silage, cultivating equipment in and out spring, summer, autumn plus the up to 10 vehicles of employees and next is the hospital which also has a lot of traffic everywhere. I hear the squeal of tyres and a good friend has had an accident at the hospital corner due to the speed needed to cross the intersection if a car is coming at 100kph when you commence. My neighbour no longer brings a cattle truck & freight onto the property for same reason, it's dangerous. please lower the limit to 60kph like Central Takaka. More reasons to lower the speed limit to 60kph, noise and vibration. I live 300 metres from the road, sometimes my house shudders when large truck and trailer units go by and there are many, it wakes me in the night along with noise with clinking and banging from the bridge to the hospital from the condition of the road, speed of trucks and the corner. It all adds up to an interrupted life from passing vehicles noise. Please lower the speed for every ones safety. So happy the bike lane will make it possible to ride without fear of being knocked off in future. Thanks for the opportunity to write.
111	Individual	I find it very noisy with the traffic passing by at 100km/h. The road past the hospital to Paines Ford and the swimming hole to me is very unsafe. \$9(2)(a)
112	Individual	I am writing as a resident of the Golden Bay Hospital. The NOISE of traffic is such that to have visitors or listen to news, one has to close doors. The screech of brakes from articulated lorries is particularly nerve racking. Yes, the speed limit should definitely be reduced. Dare to suggest even leaving it at 50km/h - as it is through town - & continue to Paines Ford? Up & down speeds in short distances ask to be broken. This is a dangerous stretch of road but noise is my big concern.
113	Individual	We agree that the proposed speed limit from Paines Ford to Takaka township should be 80km/h. It is a busy stretch of road with children, cyclists & huge heavy trucks, hospital traffic & cars constantly using it \$9(2)(a)
114	Individual	I fully endorse the lowering of the speed limit from Paines Ford to Takaka to 80km/h. Some signage with a message about looking out for children as well would be advisable especially for visitors to the Bay. This is all about keeping children safe. The walkway means children are now safe to bike & walk to the Rec Centre, to school (from Park Ave.) and to Paines Ford to swim in the summer, and having trucks etc. roaring along past them at 100km/h the walkway, is not viable.
115	Individual	Unfortunately I believe the speed limit should be dropped to 60mph before the Paines Ford Bridge and continued at 60mph until the township of Takaka at 50mph. As you have noted, this is a very vulnerable area with many people crossing and recrossing this particular area. Also after Paines Ford traffic tends to speed up again as they head towards town. Given this opportunity I want to stress the concern as to the speed limit of 50 from the Takaka Milk Factory along to the Takaka High School. This limit of 50 is not being observed, this street is very busy, children going to the school and trucks, lorries etc. except I should not include the Milk Trucks, which are very aware. The intersection at the school also meets the main road.
116	Individual	As residents and property owners on the stretch of road under consideration (State Highway 60 from the Paines Ford Bridge to Takaka) we feel strongly that the current speed limit of 100kph is excessive and dangerous. We request therefore that the speed limit on this stretch be reduced to at least 80kph, if not further. The reasons we have for this request on this section of Highway 60 are as follows - 1. The significant number of residential properties feeding onto the highway on this stretch. 2. The presence of both a busy campground, the local hospital and an upgraded Recreation Centre all fronting onto the highway. 3. The contour of the road - significant bends, often with poor visibility. 4. 6 active subsidiary streets and roads feeding onto the highway over this stretch. 5. A narrow bridge 6. Heavy traffic from Takaka going only to the hospital through a busy intersection 7. Lack of suitable footpath for most of the way 8. Changes of land use over the years with proposed new subdivision needing access to the highway. As residents on this section of highway for nearly 30 years we have seen many changes to the volumes of traffic (especially tourism) and witnessed many near accidents when accessing our driveway. Several major accidents have occurred near our entrance gate, largely due to the high speed allowed on this road, This situation is past time for change. The limit should be 70 or 80kph on the road between the Paines Ford Bridge and the Takaka township.
