

New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2012/5

Pursuant to section 61(3) of the Government Rounding Powers Act 1989, and the Land Transport Rule: Setting of Speed Limits 2003, the NZ Transport Agency hereby makes the following bylaw.

Bylaw

1. Title and commencement-

This bylaw may be cited as the New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2012/5 and will come into force 28 days after the date of publication of this notice in the New Zealand Gazette.

- Inserting new line in Schedule 2 to read:

"Section of State highway: The section of State Highway 73 at Yaldhurst from 150m east of Buchanans Road to 150m west of Buchanans Road.

Speed limit: Any time during any period specified in condition 3 of the Variable Speed Limit at Rural Intersections Notice when a variable speed limit sign installed on the section of State highway displays the numerals "70", the speed limit is 70 km/h. At all other times the speed limit is 100 km/h."

- Inserting new line in Schedule 2 to read:

"Section of State highway: The section of State Highway 24 (Broadway) at Matamata from a point approximately 80m north-west of the intersection of State Highway 24 with Vosper Street to a point approximately 60m south-east of the intersection of State Highway 24 with Hohaia Street.

Speed limit: Any time during any period specified in condition 2 of the School Zones Notice when a variable speed limit sign installed on the section of State highway displays the numerals "40", the speed limit is 40 km/h. At all other times the speed limit is 50 km/h."
