

# New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2012/6

Pursuant to section 61(3) of the Government Roading Powers Act 1989, and the Land Transport Rule: Setting of Speed Limits 2003, the NZ Transport Agency hereby makes the following bylaw.

## Bylaw

### 1. Title and commencement-

This bylaw may be cited as the New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2012/6 and will come into force 28 days after the date of publication of this notice in the New Zealand Gazette.

### 2. Amendment-

The New Zealand Transport Agency (Speed Limits on State Highways) Bylaw 2010/10\* is hereby amended by:

- Inserting new line 271A in Schedule 1 to read:

"Line No.: 271A

Region: 3

SH No.: 25

Locality: Kopu to Totara

Section of State Highway: From 450m north of the north end of Kopu Road to 50m south of Te Aripipi Road.

Speed Restriction (km/h): 80

- Amending line 273 in Schedule 1 to read:

"Line No.: 273

Region: 3

SH No.: 25

Locality: Totara

Section of State Highway: From 50m south of Te Arapipi road to 70m south of Rhodes Park entrance.

Speed Restriction (km/h): 70

- Inserting new line 508A in Schedule 1 to read:

"Line No.: 508A

Region: 5

SH No.: 35

Locality: Turihaua and Pouawa beaches

Section of State Highway: From 400m south of Pouawa Bridge to 600m south of Turihaua Bridge.

Speed Restriction (km/h): See Schedule 3

- Inserting new line 517A in Schedule 1 to read:

"Line No.: 517A

Region: 6

SH No.: 2

Locality: Westshore, Napier

Section of State Highway: From 190m north of Napier Airport entrance to 45 metres east of the intersection with SH2B at Westshore.

Speed Restriction (km/h): 80

- Inserting new line 518B in Schedule 1 to read:

"Line No.: 518B

Region: 6

SH No.: 2B

Locality: Westshore, Napier

Section of State Highway: From the intersection with Watchman Road to 360m south of Watchman Road.

Speed Restriction (km/h): 80

New Zealand Gazette Reference: 15/11/2012, No 136, page 3985"

- Inserting new line in Schedule 3 to read:

"Section of State Highway: The section of State Highway 35 north of Gisborne at Turihaua and Pouawa beaches from 400m south of Pouawa Bridge to 600m south of Turihaua Bridge.

Speed Limit: From 20 December in any year to 1 February in the following year (inclusive of those dates), the speed limit is 70km/h. At all other times the speed limit is 100km/h."
