## New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2019/4

Pursuant to section 61(3) of the Government Roading Powers Act 1989, and the Land Transport Rule: Setting of Speed Limits 2017, the NZ Transport Agency hereby makes the following bylaw.

## Bylaw

**1. Title and commencement**—This bylaw is the New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2019/4 and will come into force on and from 2 August 2019.

**2.** Amendments—The New Zealand Transport Agency (Speed Limits on State Highways) Bylaw 2010/10\* is hereby amended by:

Inserting line 217A in Schedule 1 to read: *"Line No.:* 217A *Region:* 3 *SH No.:* 1 *Locality:* Piarere *Section of State Highway:* From 228m west of the SH29 left slip island nose to 150m east of the SH29 to State Highway 1 right turn lane. *Speed Limit (km/h):* See Schedule 2 *Effective Date:* 2 August 2019 *Speed Limit Rule:* Setting of Speed Limits 2017 *New Zealand Gazette Reference:* 31/7/2019, Notice No. 2019-au3566"

- Inserting line 217A in Schedule 2 to read:
  - "Line No.: 217A
  - Region: 3

*SH No.:* 1

Locality: Piarere

*Section of State Highway:* From 228m west of the SH29 left slip island nose to 150m east of the SH29 to State Highway 1 right turn lane.

Speed Limit (km/h): Any time during any period specified in condition 3 of the Land Transport Rule: Setting of Speed Limits 2017 and Land Transport Rule: Traffic Control Devices 2004, Rural Intersection Active Warning System Variable Speed Limits – Low Cost Corridor Safety Improvements Programme, <u>New Zealand Gazette</u>, 22 June 2018, Notice No. 2018-au3033, when a variable speed limit sign installed on the section of State highway displays the numerals "60", the speed limit is 60km/h. At all other times the speed limit is 100km/h. *New Zealand Gazette Reference*: 31/7/2019, Notice No. 2019-au3566"

## **Explanatory Note**

This bylaw, which comes into force on and from 2 August 2019, amends the New Zealand Transport Agency (Speed Limits on State Highways) Bylaw 2010/10.
