

## **New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2020/16**

Pursuant to section 61(3) of the Government Rounding Powers Act 1989, and the Land Transport Rule: Setting of Speed Limits 2017, the NZ Transport Agency hereby makes the following bylaw.

### **Bylaw**

**1. Title and Commencement**—This bylaw is the New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2020/16 and will come into force on and from 18 December 2020.

**2. Amendments**—The New Zealand Transport Agency (Speed Limits on State Highways) Bylaw 2010/10\* is hereby amended by:

- Amending line 601A in Schedule 1 to read:

*“Line No.: 601A*

*Region: 7*

*SH No.: 3*

*Locality: Waitara*

*Section of State Highway: From 400m north-east of Princess Street to 440m south-west of Princess Street.*

*Speed Limit (km/h): 80*

*Date revoked: 18/12/2020*

*Speed Limit Rule: Setting of Speed Limits Rule 2017*

*New Zealand Gazette Reference: 20/11/2020, Notice No. 2020-au5268”*

- Amending line 601B in Schedule 1 to read:

*“Line No.: 601B*

*Region: 7*

*SH No.: 3*

*Locality: Bell Block*

*Section of State Highway: From 235m north-east of Mahoetahi Road to 225m south west of Mangati Road.*

*Speed Limit (km/h): 80*

*Date revoked: 18/12/2020*

*Speed Limit Rule: Setting of Speed Limits Rule 2017*

- Inserting line 601A(1) in Schedule 1 to read:

*“Line No.: 601A(1)*

*Region: 7*

*SH No.: 3*

*Locality: Waitara - Bell Block*

*Section of State Highway: From NZTM200 1709470, 5682988, approximately 300m east of Bayly Street to NZTM2000 1699596, 5678759, approximately 225m south west of Mangati Road.*

*Speed Limit (km/h): 80*

*Effective date: 18/12/2020*
