

New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2020/19

Pursuant to section 61(3) of the Government Roading Powers Act 1989, and the Land Transport Rule: Setting of Speed Limits 2017, the NZ Transport Agency hereby makes the following bylaw.

Bylaw

1. Title and commencement—This bylaw is the New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2020/19 and will come into force on and from 4 December 2020.
