

## **New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2020/21**

Pursuant to section 61(3) of the Government Roading Powers Act 1989, and the Land Transport Rule: Setting of Speed Limits 2017, the NZ Transport Agency hereby makes the following bylaw.

### **Bylaw**

**1. Title and commencement**—This bylaw is the New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2020/21 and will come into force on and from 15 December 2020
