

New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2021/1

Pursuant to section 61(3) of the Government Roading Powers Act 1989, and the Land Transport Rule: Setting of Speed Limits 2017, the NZ Transport Agency hereby makes the following bylaw.

Bylaw

1. Title and Commencement—This bylaw is the New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2021/1 and will come into force on and from 3 March 2021

2. Amendments—The New Zealand Transport Agency (Speed Limits on State Highways) Bylaw 2010/10* is hereby amended by:

- Inserting line 817A in Schedule 1 to read:
